Rehabilitation is offered as inpatient or outpatient programs with the goal to improve a person's mobility, independence in performing tasks of daily living and ability to communicate. Care team members include nurses, social worker/discharge planner, physiotherapists, occupational therapists, speech-language pathologists, recreation therapists, dietitians, and physicians.
