# Permanent Full Time Quality Coordinator NBRHC – North Bay Campus

The Quality Coordinator reports to the Director, Mental Health and works with the respective functional teams in the MH Portfolio to support quality improvement initiatives under the philosophy of More Time to Care and in alignment with the Strategic Plan. The Quality Coordinator works collaboratively with the Extended Senior Leadership Team, physicians, program leaders/teams and patients/families to make successful transformational changes by facilitating group discussions, analysing current business process and work flows, identifying opportunities for improvement and by designing, developing, testing and implementing change ideas through the application of leading-edge quality improvement strategies and techniques. In addition, the individual will be responsible for reviewing adverse events/near misses and making systemic recommendations to mitigate risk, enhance safety, improve quality and support the implementation of these recommendations.

The position requires a highly versatile, energized, and self-motivated individual. Experience and/or training in lean management, project facilitation, researching best practices, data analysis, critical incident management, risk assessment, patient/family engagement, and accreditation would prepare someone to move into this challenging and rewarding role.
