North Bay Regional Health Centre is seeking a temporary Full-time Speech Language Pathologist (SLP). The SLP is responsible for assessment, treatment, education, and counselling to patients and/or their families with swallowing and communication disorders. They will comply with standards of care as published by the College of Audiologists and Speech Language Pathologist of Ontario as well as those of the hospital. The successful candidate will work as part of a multidisciplinary team, and may be required to provide services across acute and rehabilitative populations as well as alternate level of care and complex continuing care populations.

QUALIFICATIONS INCLUDE:

- Master's Degree in Speech-Language Pathology required
 - Registered and in good standing with the College of Audiologists and Speech Language Pathologists of Ontario (CASLPO) required
 - Current Basic Life Support (BLS) for Health Care Providers (HCP) certificate required (recent within the last twelve months)
 - Current Non-Violent Crisis Intervention (NVCi) Certificate required (training delivered by Health Centre upon hire)
 - Two (2) years of experience working with adults with communication and swallowing disorders is an asset
 - Two (2) years recent experience in an acute care hospital required
 - Recent experience in intensive care, acute general medicine, and stroke is an asset
 - Experience with videofluoroscopic swallowing assessment is an asset
 - Ability to work in a multi-disciplinary team environment required
 - Strong case management skills and ability to work in a high-paced environment
 - Excellent organizational and interpersonal skills required
 - Excellent oral and written communication skills required
 - Computer competency required
