The pediatric unit at the North Bay Regional Health Centre is a six bed unit that provides general pediatric and surgical services for children up to 18 years of age. In addition there are two child/adolescent mental health beds. A team of skilled nursing staff, five pediatricians, family physicians, a recreational therapist, a social worker, a dietician and spiritual care workers provide both inpatient and outpatient care to patients up to the age of 17 years. This Unit serves also as a district Pediatric referral centre for surrounding communities as far north as New Liskeard and south to Huntsville.
