ABOUT THE POSITION

The Registered Nurse (RN) is responsible for providing safe, competent and ethical nursing care as outlined in the College of Nurses of Ontario Practice Standards and Guidelines for Ethical Behavior, North Bay Regional Health Centre (NBRHC) policies/procedures, and the standards of care appropriate to his /her area of clinical practice. RN's provide the full range of care requirements for patients with varying outcomes

ABOUT THE DEPARTMENT

A1 has a total of 21 Beds comprised of 12 Regional Geriatric Psychiatry beds and 9 Complex Continuing Care/Transition beds. Our patients are older adults with complex age related psychiatric needs complicated by behavioural and psychological symptoms, and/or medical comorbidities where care needs exceed community level support. We offer comprehensive and specialized assessments, monitoring, interventions and evaluation by therapeutic care team with a focus on recovery and community reintegration. We also provide continuing, medically complex and specialized services to those with long-term illnesses or disabilities typically requiring skilled, technology-based care that exceed community level support.

B1 is a 21 bed Dementia Transition unit where our patients are experiencing deterioration with a diagnosis of Dementia/Alzheimer or other related neurocognitive conditions and behavioral challenges that cannot be managed in the community/home or other facility (e.g. LTCH).
