ABOUT THE POSITION

The Registered Nurse (RN) is responsible for providing safe, competent and ethical nursing care as outlined in the College of Nurses of Ontario Practice Standards and Guidelines for Ethical Behavior, North Bay Regional Health Centre (NBRHC) policies/procedures, and the standards of care appropriate to his /her area of clinical practice. RN's provide the full range of care requirements for patients with varying outcomes

ABOUT THE DEPARTMENT

The Surgical Clinic operates several days a week in the Ambulatory Care Unit, handling minor surgical procedures, follow-up post-operative appointments and consultations. Day surgery patients (adults and children) receive pre and post-operative care in the day surgery department. A variety of services can have outpatient day surgery procedures: General surgery, Dental surgery, Ear, nose and throat, Orthopedics, Urology, Gynecology

Certification/Experience/Knowledge:

- Current Basic Life Support (BLS) for Health Care Providers (HCP) Certificate is required (recent within the last twelve months)
- Current certificate in I.V. Therapy required
- Recent broad Ambulatory Care experience required (within the last 3 years) including Surgical Ambulatory Clinics, Chemotherapy, Endoscopy, Cystoscopy
- Current Non-Violent Crisis Intervention (NVCI) Certificate (training delivered by Health Centre upon hire)
- Provincial Standardized Chemotherapy and Biotherapy course from deSouza Institute required
- Wound debridement certification required
- Minimum (2 - 3 years) Medical/Surgical experience (within the last 2-3 years) required
- Interest and willingness to work in a variety of clinic settings required
- Port-a-caths and PICC line certifications required
- Phlebotomy certification required
- Knowledge of adult and paediatric teaching and learning principles

- Must demonstrate excellent level of interpersonal skills
- Must demonstrate excellent level of written and verbal communication skills
- Ability to work both independently and collaboratively with all members of the multidisciplinary team, clients, families, regional support services and community partners required
- Ability to provide health teaching to individuals and groups required
- Must be committed to continuing education on an annual basis and demonstrate commitment to quality improvement required
- Ability to effectively assume a leadership role as a collaborative member of the health team required
- Ability to assume responsibility for patient care in a total patient care climate required
- Able to meet the physical demands required to provide nursing care to all patients required
- Ability to problem-solve and function in fast-paced environment required
- Excellent demonstrated assessment, critical thinking and intervention skills required
- Must demonstrate basic computer knowledge
- Must demonstrate commitment to ensure personal safety, safety of fellow workers, patients, volunteers, and visitors
- Ability to support and contribute to a culture of safety and prevention of adverse health events required
- Must demonstrate good attendance and work record
- Bilingualism (Advanced level English/French) is required. **All unilingual candidates are encouraged to apply and may be considered if the identified French requirement has been met or there are no successful bilingual candidates. A formal French test will be conducted to evaluate the proficiency level.**
