Based primarily in the community setting, this role will contribute to the advancement of BSO's three pillars: System Coordination & Management; Integrated Service Delivery: Intersectoral & Interdisciplinary; and Knowledgeable Care Team & Capacity Building. Reporting directly to the North East BSO Regional Manager and Coordinator with clinical guidance from NE BSO Central Lead, this seasoned clinician will embody compassionate, person-family focused values aligned with NBRHC's values and BSO's guiding philosophies and frameworks.
