# JOB DESCRIPTION

As an integral member of the Perioperative Services team, the Room Based Attendant performs direct and indirect patient care functions under the direction of a regulated healthcare provider within the surgical portfolio. Roles and responsibilities of this position include, but are not limited to the following:

- perform assigned tasks and duties consistent with the job classification and unit specific assignment as it aligns with standard of work and service
- responsible for assisting and/or the positioning of patients
- responsible for the tasks related to environmental services such as Operating Room turnovers between surgical cases
- responsible for the transporting of patients using a variety of transportation methods
- · responsible for the transporting of specimens to the lab
- responsible for stocking and restocking of supplies
- · responsible to provide ongoing support to the Perioperative Services team as required

- Current Basic Life Support (BLS) Certificate required (recent within the last twelve months)
