The Registered Nurse (RN) is responsible for providing safe, competent and ethical nursing care as outlined in the College of Nurses of Ontario Practice Standards and Guidelines for Ethical Behavior, North Bay Regional Health Centre (NBRHC) policies/procedures, and the standards of care appropriate to his /her area of clinical practice. RN's provide the full range of care requirements for patients with varying outcomes

**ABOUT THE DEPARTMENT**

The Critical Care Unit is a 16-bed specialized unit caring for critically ill patients who require constant monitoring and whose conditions can be life threatening.

Low nurse to patient ratios assure close monitoring and early detection of any subtle changes in patient condition. We provide care to cardiac, medical and surgical patients (from pediatric to geriatric)

A team of specially educated and experienced staff deliver specialized care with state-of-the-art monitoring systems. The team consists of Anaesthetists, Internists, Surgeons, Registered Nurses, Registered Respiratory Therapists, Physical Therapists, Occupational Therapists, Pharmacists, Dietitians, Social Workers, and Pastoral Care.

The Emergency Department is open 24 hours a day, 7 days per week. It is staffed by a multi-disciplinary team of registered nurses, registered respiratory therapists, social services, pastoral care, crisis intervention, orthopedic technicians and other members of our health care team.

- Demonstrated ability to triage/prioritize patient care
- Courses in: Critical Care Nursing; Emergency Nursing; Trauma Management; Coronary Care and Emergency Nursing Certification preferred

  - Ability to problem-solve and function in fast-paced environment required
  - Excellent demonstrated assessment, critical thinking and intervention skills required
  - Must demonstrate basic computer knowledge
